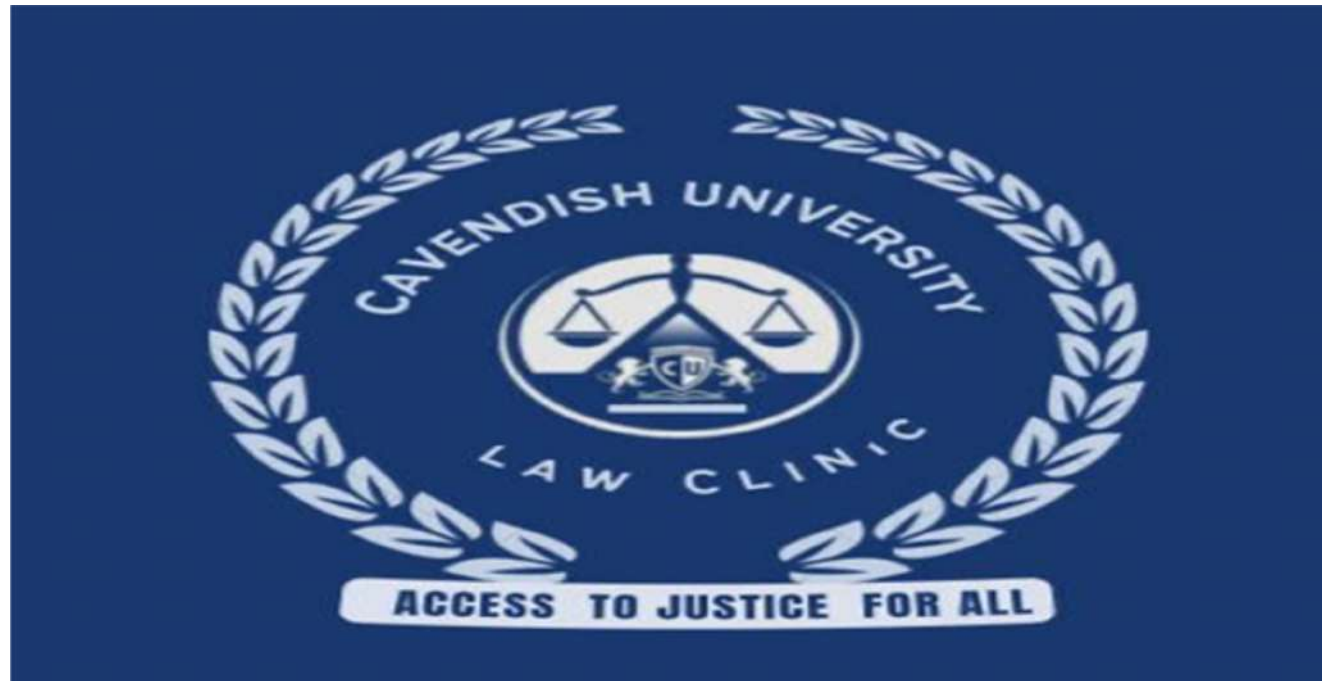
- **NEEDS IDENTIFICATION**

- The education of the lawyer never ends because they must constantly be abreast of information which may be of use to the client.
- Our world in the 21st century is changing rapidly.

- Traditional legal education failed to teach the students the practice of the law being narrow and rigid in its methods

- **CUU LAW SOLUTION**

- Using CLE & Mooting as veritable tools involving the Community as industry and stakeholders
- CLE programme in CUU – Engages in advocacy campaigns and supporting other stakeholders in the efforts to consolidate, update, and modernize the law on legal aid in Uganda and codify Government's obligation to provide legal aid Uganda
- Identifying aspects of the justice system that requires improvement
- Establish clear goals towards the realization of a select social justice issue on a target population

## CLE –Law Clinic as a Strategy



- Law Clinics provide hands-on opportunities to learn and practice lawyering skills and legal analysis, and also to serve a social justice platforms for providing access to justice through legal assistance to the indigent is relatively new in Uganda and Cavendish is one of the pioneering Institution.
- The Law Clinic at CUU has focused on training students on CLE and justice education since inception by inculcating Community Projects and collaboration with Government Institutions and Non-Govt Organisation (NGO).
- Collaboration with Government Revenue Office to educate the Public on the basics of Taxation and the importance in the growth of business albeit small scale/large scale
- Protection of vulnerable populations
- Capacity to deter violence
- Enhance people's trust in formal institutions

□ The best performers from the intra-faculty moots are selected to represent the University in national, regional and International Moot court competitions. **(Capacity building)**

□ Through the Intra-Moots, legal research and writing skills, Oral advocacy skills are harnessed to enable the students develop team work as well as training them how to **work under pressure** among the development of other skills that are market relevant for the legal profession.
